Child Nutrition Eligibility & Education Benefit- CNEEB

Reminder:

What is the The Child Nutrition Eligibility & Education Benefit (CNEEB) Application?

• This new application merges the free and reduced-price meal application and family income survey.

Who is required to distribute the CNEEB Application?

• All school districts operating the NSLP/SBP, including those operating CEP or Provision 2 district-wide, are required to distribute the CNEEB Application beginning in school year <u>2024-25</u>.




Child Nutrition Eligibility & Education Benefit- CNEEB

Qmlativ Configuration Review:

As of April 2025, programmatic updates were implemented for the Child Nutrition Eligibility & Education Benefit Application (CNEEB) in Qmlativ. Districts with any CEP (Community Eligibility Provision) entities must update their configuration to fully implement this functionality.

- 1. Confirm configuration (District Level per School) has been updated to identify whether the school participates in CEP for the 2025-2026 School Year.
- 2. Confirm that the configuration (District Level) for the online application process has been updated to reflect the latest CNEBB logic.
 - a. If appropriate- Update Letter to Households to include Both Non-CEP and CEP Schools.
 - i. <u>Application Materials Letters to Households</u>
 - b. Review Application Step Area. If overrides are present, remove and save.
 - i. If applicable, remove override for Step 4 (Household size & Last 4 SSN).
 - ii. If applicable, remove override from Step 5 (Contact Information & Signature).
